

CHICKASAW TRIBAL LEGISLATURE
General Resolution Number 19-039
Utility Easement in McClain County
(Sewer Services)

WHEREAS, in accordance with Article VII, Sections 4 and 7 of the Constitution of the Chickasaw Nation, the Chickasaw Tribal Legislature shall enact rules and regulations pertaining to the Chickasaw Nation, and shall make decisions pertaining to the acquisition, leasing, disposition and management of real property, subject to federal law, and

WHEREAS, in accordance with Article XI, Section 1 of the Constitution of the Chickasaw Nation, the Governor shall perform all duties appertaining to the Office of Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, the Bureau of Indian Affairs, Chickasaw Agency is responsible for administering restricted and trust property; and

WHEREAS, a 20' utility easement is requested by the Purcell Public Works Authority for sewer service for the proposed nutrition services center in Purcell, within the NW/4 of Section 13, Township 6 North, Range 2 West, more particularly described as: Commencing at the Southwest corner of said NW/4; Thence South 89E50'54" East a distance of 182.90 feet to the Point of Beginning of this easement; Thence North 00E00'04" West a distance of 304.00 feet to the Point of Termination, McClain County, Oklahoma, and

WHEREAS, because this easement provides sewer services to the nutrition services center, compensation is hereby waived.

NOW, THEREFORE, BE IT RESOLVED, that the Chickasaw Tribal Legislature hereby authorizes and approves the proposed sewer line utility easement to the Purcell Public Works Authority across tribal property in McClain County for the construction of a nutrition services center in Purcell.

Executed in regular session of the Chickasaw Tribal Legislature, meeting at Ada, Oklahoma, on April 19, 2002, by a vote of 12 ayes, 0 nays, and 0 abstentions.
