

CHICKASAW TRIBAL LEGISLATURE
General Resolution 23-039
Affirming General Resolution 23-023
(Authorizing an Acquisition of Property in Pontotoc County)

WHEREAS, in accordance with Article VII, Sections 4 and 7 of the Constitution of the Chickasaw Nation, the Chickasaw Tribal Legislature shall enact rules and regulations pertaining to the Chickasaw Nation, and shall make decisions pertaining to the acquisition, leasing, disposition and management of real property subject to federal law, and

WHEREAS, in accordance with Article XI, Section 1 of the Constitution of the Chickasaw Nation, the Governor shall perform all duties appertaining to the office of Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, this resolution more specifically describes the complete legal description of a tract of land in Ada, Pontotoc County, Oklahoma, described as follows: A part of the N/2 of the SE/4 of the NW/4 of Section 28, Township 4 North, Range 6 East, Ada, Pontotoc County, Oklahoma, more particularly described as follows: Beginning at a point 80 feet South of the Northeast corner of said N/2 of SE/4 of NW/4; thence West a distance of 242.2 feet; thence South a distance of 40 feet; thence West a distance of 537.23 feet; thence South a distance of 209.44 feet; thence East a distance of 779.18 feet; thence North a distance of 248.59 feet to the point of beginning, containing 4.02 acres, more or less, and hereby affirms General Resolution 23-023, previously approved on December 16, 2005.

NOW, THEREFORE, BE IT RESOLVED, that General Resolution 23-023 is hereby affirmed for the purpose of more specifically identifying the complete legal description as requested by the Bureau of Indian Affairs for placing said tract of land U.S.A. in trust for the Chickasaw Nation.

Executed in regular session of the Chickasaw Tribal Legislature, meeting at Ada, Oklahoma, on February 17, 2006, by a vote of 11 ayes, 0 nays and 0 abstentions.
