**Approval of Application for Funding – Administration for Native Americans
Family Preservation-Improving the Well-being of Children Project Implementation**

WHEREAS, in accordance with Article VII, Sections 4 and 7 of the Constitution of the Chickasaw Nation, the Chickasaw Tribal Legislature shall enact rules and regulations pertaining to the Chickasaw Nation, and shall make decisions pertaining to the acquisition, leasing, disposition and management of real property, subject to federal law, and


WHEREAS, in accordance with Article XI, Section 1 of the Constitution of the Chickasaw Nation, the Governor shall perform all duties appertaining to the office of Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, the Administration for Native Americans (ANA) has funds available to assist the Chickasaw Nation in establishing a state-of-the-art family resource center to improve the well-being of children, family relationships and Native communities, and


WHEREAS, the Chickasaw Nation has discussed the goals regarding the Family Preservation-Improving the Well-being of Children project implementation grant with its citizens through community council meetings and legislative sessions which have allowed citizen input and feedback sufficient for the Chickasaw Nation to identify the need for approaches to remove barriers to forming lasting families and healthy marriages in Native communities.

NOW, THEREFORE, BE IT RESOLVED, that the Chickasaw Tribal Legislature hereby supports and approves of the Chickasaw Nation's application to the U.S. Department of Health and Human Services, Administration of Children and Families, for funding through the Administration for Native Americans for its Family Preservation-Improving the Well-being of Children project implementation grant.


