General Resolution Number 26-035

To Replace General Resolution 25-059

(Authorization for Acquisition of Real Property in Pontotoc County)

WHEREAS, in accordance with Article VII, Sections 4 and 7 of the Constitution of the Chickasaw Nation, the Chickasaw Tribal Legislature shall enact rules and regulations pertaining to the Chickasaw Nation, and shall make decisions pertaining to the acquisition, leasing, disposition and management of real property subject to federal law, and


WHEREAS, in accordance with Article XI, Section 1 of the Constitution of the Chickasaw Nation, the Governor shall perform all duties appertaining to the office of Chief Executive. He shall sign official papers on behalf of the Nation, and


WHEREAS, this resolution more specifically describes the complete legal of a tract of land in Ada, Pontotoc County, Oklahoma, described as follows:

The SW/4 of NW/4 of SE/4 and a tract in the W/2 of SW/4 of SE/4, more particularly described as follows: Beginning at the Northwest corner of said W/2 of SW/4 of SE/4; thence S 89°57'08" E along the North line of said W/2 of SW/4 of SE/4 a distance of 661.54 feet to the East line of said W/2 of SW/4 of SE/4; thence S 00°00'43" E along the East line a distance of 708.70 feet to the centerline of the abandoned M&P Railroad; thence N 57°54'13" W along said centerline a distance of 781.07 feet to the West line of said W/2 of SW/4 of SE/4; thence North along said West line a distance of 294.24 feet to the point of beginning, all in Section 28, Township 4 North, Range 8 East, Pontotoc County, Oklahoma, containing 17.63 acres, more or less.

NOW, THEREFORE, BE IT RESOLVED, that General Resolution 25-059 is hereby replaced for the purpose of more specifically identifying the complete legal description as requested by the Bureau of Indian Affairs for placing said tract of land U.S.A. in trust for the Chickasaw Nation.

Executed in regular session of the Chickasaw Tribal Legislature, meeting at Ada, Oklahoma, on April 17, 2009, by a vote of 11 ayes, 0 nays and 0 abstentions.
