Gubernatorial Reappointment to the Board of Directors of
the Chickasaw Historical Society
Ms. Debbie Jackson

WHEREAS, in accordance with Article VII, Sections 4 and 7 of the Constitution of the Chickasaw Nation, the Chickasaw Tribal Legislature shall enact rules and regulations pertaining to the Chickasaw Nation, and shall make decisions pertaining to the acquisition, leasing, disposition and management of real property, subject to federal law, and

WHEREAS, in accordance with Article XI, Section 1 of the Constitution of the Chickasaw Nation, the Governor shall perform all duties appertaining to the office of Chief Executive. He shall sign official papers on behalf of the Nation, and


WHEREAS, Section 6.(a) of the Chickasaw Historical Society Act of 1994 makes provision for the Governor of the Chickasaw Nation to appoint a Board of Directors for the Chickasaw Historical Society which shall be comprised of not less than seven (7) regular members, each of whom shall be confirmed by the Chickasaw Tribal Legislature, and

WHEREAS, Governor Bill Anoatubby has reappointed Ms. Debbie Jackson to serve on the Board of Directors of the Chickasaw Historical Society to fill an unexpired term, and


WHEREAS, Ms. Jackson is a citizen of the Chickasaw Nation, and is fully qualified to sit on that Board.

NOW, THEREFORE, BE IT RESOLVED, that the Chickasaw Tribal Legislature hereby confirms the gubernatorial reappointment of Ms. Debbie Jackson to the Board of Directors of the Chickasaw Historical Society, with a term of office ending on October 1, 2011.


