CHICKASAW TRIBAL LEGISLATURE

General Resolution Number 26-045

Authorization for Granting of Real Property in Murray County

WHEREAS, in accordance with Article VII, Sections 4 and 7 of the Constitution of the Chickasaw Nation, the Chickasaw Tribal Legislature shall enact rules and regulations pertaining to the Chickasaw Nation, and shall make decisions pertaining to the acquisition, leasing, disposition and management of real property, subject to federal law, and

WHEREAS, in accordance with Article XI, Section 1 of the Constitution of the Chickasaw Nation, the Governor shall perform all duties appertaining to the office of Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, the Land Development Committee recommends granting to the Housing Authority of the Chickasaw Nation, vacant real property in Sulphur, Murray County, Oklahoma, described as follows:


A part of the NE $\frac{1}{4}$ of Section 33, Township 1 North, Range 3 East of the Indian Meridian, Murray County, Oklahoma, and being more particularly described as follows: the East 87.0 feet of the West 528.0 feet of the S $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ of said Section 33,

together with all improvements thereon, if any, in their present condition, ordinary wear and tear excepted, and

WHEREAS, the Housing Authority of the Chickasaw Nation shall utilize the property in accordance with the Native American Housing Assistance and Self Determination Act (NAHASDA).

NOW, THEREFORE, BE IT RESOLVED, that the Chickasaw Tribal Legislature hereby authorizes and approves the Governor of the Chickasaw Nation, or his designee, to conclude the granting of said property, free and clear, from the Chickasaw Nation to the Housing Authority of the Chickasaw Nation.



together with all improvements thereon, if any, in their present condition, ordinary wear and tear excepted.
