General Resolution Number GR 26-072

**Acknowledgment of Formation of Global Gaming RP, LLC**

**WHEREAS,** in accordance with Article VII, Sections 4 and 7 of the Constitution of the Chickasaw Nation, the Chickasaw Tribal Legislature shall enact rules and regulations pertaining to the Chickasaw Nation, and shall make decisions pertaining to the acquisition, leasing, disposition and management of real property, subject to federal law, and

**WHEREAS,** in accordance with Article XI, Section 1 of the Constitution of the Chickasaw Nation, the Governor shall perform all duties appertaining to the office of chief executive. He shall sign official papers on behalf of the Nation, and

**WHEREAS,** Global Gaming Solutions, LLC (hereinafter "GGS, LLC"), is a limited liability company organized in the state of Delaware on October 22, 2007, and

**WHEREAS,** the Board of Directors (hereinafter "Board") of GGS, LLC is appointed by the Governor and confirmed by the Chickasaw Tribal Legislature, and


**WHEREAS,** the Board is charged with conducting the operations and functions of GGS, LLC, and,


**WHEREAS,** the Board, in order to carry out said operations and functions, has determined that it is necessary to form a sub-entity, Global Gaming RP, LLC, and formally seeks the acknowledgment of said sub-entity by the Chickasaw Tribal Legislature.


**NOW, THEREFORE, BE IT RESOLVED,** that the Chickasaw Tribal Legislature herewith acknowledges the formation of Global Gaming RP, LLC by Global Gaming Solutions, LLC as a for profit limited liability company formed under the laws of the state of Oklahoma, without sovereign immunity, for the purpose of operating a horse racing track and casino in Oklahoma City, Oklahoma;

**BE IT FURTHER RESOLVED,** that the Chickasaw Tribal Legislature herewith agrees that the company is not immune from unconsented suit, liability, judgment and collection in federal courts and Oklahoma state courts and agrees that the company shall be subject to Oklahoma state law, the jurisdiction of the federal courts and state courts of Oklahoma, and the jurisdiction, regulation and enforcement of the Oklahoma Horse Racing Commission.

Executed in regular session of the Chickasaw Tribal Legislature, meeting at Ada, Oklahoma, on August 21, 2009, by a vote of 9 ayes, 1 nays, and 0 abstentions.
