CHICKASAW TRIBAL LEGISLATURE

General Resolution Number 27-002

Authorization for Acquisition of Real Property in Pontotoc County

WHEREAS, in accordance with Article VII, Sections 4 and 7 of the Constitution of the Chickasaw Nation, the Chickasaw Tribal Legislature shall enact rules and regulations pertaining to the Chickasaw Nation, and shall make decisions pertaining to the acquisition, leasing, disposition and management of real property, subject to federal law, and


WHEREAS, in accordance with Article XI, Section 1 of the Constitution of the Chickasaw Nation, the Governor shall perform all duties appertaining to the office of Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, the Land Development Committee recommends the acquisition of real property, in Ada, Pontotoc County, Oklahoma described as follows:


All of Lots 20 and 21 in Block 91, Original Ada, Pontotoc County Oklahoma together with all improvements thereon, if any, in their present condition, ordinary wear and tear excepted.

NOW, THEREFORE, BE IT RESOLVED, that the Chickasaw Tribal Legislature hereby authorizes and approves the Governor of the Chickasaw Nation, or his designee, to negotiate the acquisition and conclude a Contract for the above described tract of land. Such contract shall be for a price not to exceed the Market Value Price, in accordance with the Constitution and Laws of the Chickasaw Nation and those Rules and Regulations of the Bureau of Indian Affairs and the United States Department of the Interior, as they may apply to such acquisition. The Governor is authorized to request the Bureau of Indian Affairs to place the property U.S.A. in Trust for the Chickasaw Nation after acquisition, if such action is advantageous.


