**CHICKASAW TRIBAL LEGISLATURE**  
**Permanent Resolution Number 29-002**  
**Amendments to Titles 1 and 2 of the Chickasaw Nation Code**  
**(Corrections)**

**WHEREAS,** in accordance with Article VII, Sections 4 and 7 of the Constitution of the Chickasaw Nation, the Chickasaw Tribal Legislature shall enact rules and regulations pertaining to the Chickasaw Nation, and shall make decisions pertaining to the acquisition, leasing, disposition and management of real property, subject to federal law, and

**WHEREAS,** in accordance with Article XI, Section 1 of the Constitution of the Chickasaw Nation, the Governor shall perform all duties appertaining to the office of Chief Executive. He shall sign official papers on behalf of the Nation, and

**WHEREAS,** the Chickasaw Tribal Legislature has previously enacted laws codified in Titles 1 and 2 of the Chickasaw Nation Code, and

**WHEREAS,** the Tribal Legislature desires to amend those laws.

**NOW, THEREFORE, BE IT RESOLVED,** that the Chickasaw Tribal Legislature hereby approves and adopts the following amendments to Titles 1 and 2 of the Chickasaw Nation Code, all other sections and parts of sections to remain the same (additions are shown in red, deletions are stricken through):




