Homeowner Preparedness Grant Information Sheet

The Homeowner Preparedness Grant can be used to prepare your home for weather events and/or natural disasters.

Some preparedness items may require a licensed professional such as electrical and storm shelter construction. Some items, such as pier wrapping, may be purchased directly through a vendor. You may contact a contractor or vendor in your area and have the business provide an estimate for your preparedness items. Each estimate must list the contractor's or vendor's name, address and phone number. The estimate must include where the work is being done (your name and address). Estimates must be itemized, for instance, materials and labor. Once approved, a check will be issued and made payable to applicant and the contractor or vendor. Reimbursement cannot be made for any items or services completed prior to our notification to applicant of grant availability.

Once your application is approved, your estimate(s) can be mailed to P.O. Box 788, Ada OK 74820, sent by fax to 580-421-8885 or emailed to AdmissionsDept@Chickasaw.net. The estimate for improvements must be received within 30 days of the date of the approval letter.

Examples of eligible items for home improvement grants include, but are not limited to the following:

1. Storm shelters
2. Storm shutters
3. Sandbags
4. Pier wrapping
5. Generators
6. Other items on a case-by-case basis

Examples of ineligible items include, but are not limited to the following:

1. Any item that does not provide preparedness for weather events and/or natural disasters.
